## Disaster Logistics Training



As the Region continues to recover from Superstorm Sandy, many jurisdictions will begin evaluating their plans and training to ensure they are prepared when the next storm strikes. To support these efforts, the Regional Logistics Program (RLP) is pleased to offer training designed to expand a jurisdiction's capacity for disaster logistics.

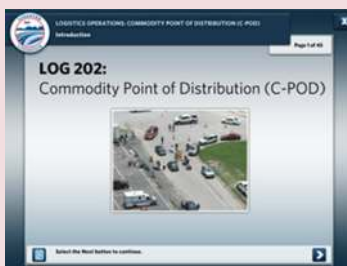
The RLP's disaster logistics training program consists of a modular series of four web-based courses that take no more than five hours to complete all together. Each web-based course is complemented by a Just-in-Time (JIT) video that runs between 12 and 15 minutes. All courses have been designed to provide users with the disaster logistics knowledge they need to step in and assist when they are needed most.



The introductory course, *LOG 101: The Disaster Logician*, teaches the basic principles of logistics and the challenges of disaster logistics in particular. The remaining courses – *LOG 200: Logistics Center*, *LOG 201: Receiving and Distribution Center*, and *LOG 202: Commodity Point of Distribution* - are based on the plans developed by the Regional Logistics Program.



In addition to the web-based format, all courses are available as instructor led classroom trainings which allow information to be tailored to local needs, policies and procedures. Classroom instruction allows students to discuss the concepts presented in the plans and relate them to the specific processes found in their own jurisdiction. In addition, those students new to logistics will meet and learn with fellow future logisticians.

The *Area Logistics Emergency Response Team (ALERT) Field Operations Guide (FOG)* and the *ALERT Implementation Guidance Document* are now available. The *ALERT FOG* outlines the mission, concept, and structure of ALERT as well as the responsibilities and job functions of ALERT members. The *ALERT Implementation Guidance Document* helps local jurisdictions introduce the ALERT program to their local EOC by providing a strategic overview of the ALERT concept.

### Movement Controller

Final recommendations for the *Movement Controller* project are being reviewed this month. A proposed architecture for the tool, including database and information requirements, is being developed. This project will use results of the existing program assessments of rail, air, land, and maritime infrastructure to create a recommendation for how to develop a computer application tool that enables logistics personnel to optimize the flow of critical resources into the NY-NJ-CT-PA Project Site following a catastrophic incident. ## Regional Resource Management Solution (RRMS/RIMS)

The *EDXL-RM Research and Evaluation* project is preparing to run a simulation using the Emergency Data Exchange Language-Resource Messaging (EDXL-RM) standard to pass resource request messages among regional incident management systems. The EDXL-RM standard provides a structure for sharing resource management data among agencies as resources are requested and deployed in emergencies.
